



iValidate Mule Card Reader Equipment & Software Use

Terms and Conditions (“Terms”)

Please read these Terms and Conditions (“Terms”, “Terms and Conditions”) carefully before using any iValidate Mule Card Reader device and software (the “Service”) managed by the University of Central Missouri's Campus Card Center (“us”, “we”, or “our”). Mule Card is the official University of Central Missouri student ID and the nexus of processing transactions with the devices and their software.

Your access to and use of the Service is conditional on your acceptance of and compliance with these Terms. These Terms apply to anyone (“Authorized Users”) who accesses or uses the Service. Authorized users have been assigned to perform the duties in which the service is being used.

By accessing or using the Service you agree to comply with these Terms. If you disagree with any part of the terms then you may not access the Service.

Period of Terms and Conditions

The period of use will begin at the moment the device(s) is received by you or your proxy, and will end when the device(s) is returned to the Campus Card Center.

Requirements for Use of Service

The following measures are required to be taken by all parties using the Service:

- Any device using the service must be secured to a person or stand at all times during use.
- The report data will be deleted from the device at the end of each use within 1 business day of when the report has been received.
- Only authorized staff shall have access to the Service.

These terms are in place to protect the privacy of the clients and as such are non-negotiable.

Use and Care of Equipment and Information

When an iValidate Mule Card Reader device is borrowed from the Campus Card Center, the device must be returned in the same condition in which it was received. The equipment shall not be altered or disfigured in any way. Any significant physical damage, or damage resulting in equipment being rendered unusable, or loss of the equipment, will result in an equipment replacement fee equal to the actual replacement cost.

Information collected is for the use of the transaction and the information is not to be shared with anyone other than Authorized users.



Confidential information shall not be used for any purpose(s) explicitly outlined below:

- Any solicitation and / or donation campaigns
- Selling or giving customer / person lists to other organizations for any purposes including but not limited to telemarketing, donation, or sales solicitations.
- Sales demonstrations, Software testing

Termination

We may terminate or suspend access to our Service immediately, without prior notice or liability, for any reason whatsoever, including without limitation if the Terms are breached.

All provisions of the Terms which by their nature should survive termination shall survive termination, including, without limitation, ownership provisions, warranty disclaimers, indemnity and limitations of liability.
